

## School for Justice Privacy Policy

Last updated: 7 February 2017

In this Privacy Policy ("**Policy**"), we describe how we collect, manage, store and otherwise process personal data regarding the use of the website [www.schoolforjustice.com](http://www.schoolforjustice.com) ("**Website**") or one of its sub-domains. By continuing your visit to the Website you accept the practices described in this policy.

### How do we collect data?

We collect personal data that you provide to us directly if you:

- Make a donation;
- Subscribe to our newsletter

Furthermore, we collect data which is automatically generated during your visit of the Website through the use of cookies. These for instance include cookies on the Website through the use of Google Analytics and Stripe.

### What data do we process?

The only information we collect when you visit the Website (browsing) is from standard server logs. These include your:

- IP (Internet Protocol) Address,
- Domain Name,
- Browser Type,
- Operating System, and
- Information such as the website that referred you to us, the files you downloaded, the pages you visited, and the date and time of those visits.

If you make a donation, we collect information about you, such as your:

- Name

- E-mail address
- General payment data (such as your bank account no. and your name)

If you subscribe to our newsletter, we collect information about you, such as your:

- Name
- Email address

### **Referral to other sites.**

You may get redirected to other sites through a hyperlink or other referral placed on the Website. This Policy will not apply to those sites. Please review the Privacy Policies of these respective websites, as they may differ from this Policy. Sites referred to on the Website include:

- Facebook
- Youtube
- Twitter

### **What is the purpose of the collection of your data?**

We use your data in connection with our Website and the donations made. This means, we use your data to:

- Allow you to visit and navigate through our Website;
- Create, maintain and improve our Website and its user experience;
- Tailor our Website to your needs as much as possible;
- Promote our Website;
- Fulfil our legal obligations, such as obligations to store some of your personal data or to provide it to third parties or authorities (only if we are legally obliged);
- Perform research or prepare analyses and reports regarding content viewed or skipped by users (on the basis of anonymous and cumulative data).

### **How do we store your data?**

Your personal data may be stored outside of the Netherlands, and/or outside of the European Economic Area ("EEA"). Moreover, we use providers of storage and other ICT services. We undertake to only use suppliers who respect your privacy and when using and contracting suppliers we will ensure compliance with applicable data protection laws. The only processing activities carried out by a storage provider will be for the purpose of storing your data. No other processing activities will be applied to your data, except as set out above.

### **Who may use or receive your data?**

Your data is used by our employees, and the employees of affiliates and subcontractors /service providers when you use our Website as described in this Policy. We ensure that our employees may only access your personal data to the extent necessary for the fulfilment of their tasks.

If we share your personal data with an affiliate (such as a parent company, subsidiary or other company under a common management), we require them to respect the guidelines set out in this Policy and to only process your personal data in a fair and legitimate manner.

If we share your personal data with other third parties (such as subcontractors or service providers), we require such parties to process personal data confidentially and securely and to use the data exclusively for the purpose of providing us with the requested product or service.

If legally permitted, we may share personal data with credit management companies. In certain cases, we may be legally required to hand over personal data to third parties or legal authorities.

### **Cookies**

As mentioned, one of the techniques we use to collect personal data is the use of cookies; small text files containing information about your navigation through our website, of which the main goal is to analyse trends and usage of the website and to improve the user experience of the site.

We use Google Analytics to measure and analyse visitor information. This information contains data concerning which web pages are visited most, the average duration of each visit to the Website, which browsers are used most etc. The information is not used to identify individual users of the Website.

We use functional cookies to ensure the proper operation of the Website and to provide you with a pleasant user experience. Such functional cookies may be operated by third parties, such as Stripe, who operate as the payment provider for donors.

Free a Girl Foundation uses social media such as, but not limited to, Facebook, Youtube and Twitter on the Website. These social media providers may use cookies, for example to measure clicking behaviour.
